BOOSTER JUICE "Canadian Getaway Giveaway 2022" CONTEST RULES

THE BOOSTER JUICE "Canadian Getaway Giveaway 2022" (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN CANADA ONLY (EXCLUDING QUEBEC) AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS CAN BE ANY AGE; WINNERS UNDER THE AGE OF 15 MUST CLAIM THEIR CONTEST PRIZE WITH SOMEONE OVER THE AGE OF MAJORITY IN THEIR RESPECTIVE PROVINCE. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- 1. **ELIGIBILITY.** To be eligible for the Contest, an individual must:
 - (a) Be a legal resident of Canada (excluding residents of Quebec)
 - (b) Participants under the age of 15 must claim their contest prize with someone over the age of majority in their respective province
 - (c) Reside in Canada, or be able to utilize the grand prize in Canada
 - (d) The winner and guest must all have a valid driver's license or valid proof of identification to travel within Canada
 - (e) Have no current or prior record or restrictions to travel freely within Canada

Employees of AW Holdings Corp., Booster Juice Franchise locations (the "Sponsors"), their respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members of any of the above, are not eligible to participate in the Contest.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

2. CONTEST PERIOD.

The Contest begins at 7 a.m. Eastern Standard Time ("EST") on Friday, July 1, 2022 until store closing on Sunday July 31, 2022 (the "Contest Period") after which time the Contest will be closed and no further entries will be accepted.

3. HOW TO ENTER.

- (a) Upon the purchase of any Booster Juice smoothie at any of the participating Booster Juice locations across Canada, the Contest will require the participant to post a photo of their smoothie in the limited edition Canada Cup to social media using the hashtag #TravelWithBoosterJuice and tagging us @BoosterJuice and tell us where you want to go in Canada.
- (b) There is no purchase necessary to enter the Contest. No purchase necessary entry into the Contest will require a five hundred (500 word) essay outlining why you like Booster and why you should be selected to win a trip across Canada. This must be submitted to marketing@boosterjuice.com by July 31, 2022 at 11:59pm EST.
- (c) Customers may submit multiple entries, so long as each entry is accompanied by a unique Booster Juice purchase, or a new 500-word essay submission.
- (d) All entries become the sole property of the Sponsors and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with the individual selected as the winner ("Contest Prizes").

4. GRAND PRIZE.

There is one (1) grand prize ("Grand Prize") available to be won by one (1) grand prize winner ("Grand Prize Winner") which shall consist of accommodation and roundtrip airfare tickets for two (2) to anywhere in Canada that WestJet travels with accommodations for four (4) nights and five (5) days. The Winner can submit a request for their preferred hotel and flight plan once the prize has been announced and claimed, however the Winner and the Sponsors must be in final agreement of the itinerary details and price.

- (a) Grand Prize will be awarded in the form of two (2) round-trip economy airfare tickets for the Grand Prize Winner and his/her guest, (the "Guest"), who must be of the age of majority in his/her province of residence at the time of travel booking, or if underage, traveling with immediate family. The Winner and guest must all be leaving together from the same gateway at one (1) of the following Canadian airports in: Calgary, Charlottetown, Edmonton, Fredericton, Halifax, Saskatoon, Regina, Ottawa, Saint John, St. John's, Toronto, Vancouver, Whitehorse or Winnipeg.
- (b) In association with the round-trip economy airfare, accommodation for four (4) nights, five (5) days (based on flight times) will be granted to the Winner and Guest, with one (1) room based on occupancy for two (2). All travel arrangements and details will be handled and selected by Sponsors at their sole discretion for the Winner and Guest. Travel related terms and conditions apply.
- (c) Prize has an approximate value of \$7,500 CAD. Actual value of Prize will depend on departure city and accommodations. The prize cannot exceed this amount.
- (d) Winner and his/her Guest travel time will be determined upon winner selection and coordinated with the Winner and Sponsors. Departure and Arrival dates of trip will be authorized from the date of announcement to December 31, 2022 excluding peak travel times. Should the Winner and/or Guest be unable to travel on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner. Winner and Guest will be responsible for transportation to and from originating airport (such airport is the airport from which the Prize commences therefore if the Winner is located in a city other than those listed in section 4(a), Winner and Guest shall be responsible for the cost and expense of getting themselves to the airport in Calgary, Charlottetown, Edmonton, Fredericton, Halifax, Saskatoon, Regina, Ottawa, Saint John, St. John's, Toronto, Vancouver, Whitehorse or Winnipeg. - (e) Grand Prize Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (f) Grand Prize will be distributed after Grand Prize Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.
- (g) Grand Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused portion of a Grand Prize will be forfeited and have no cash value. The Sponsors reserve the right, in its and their sole discretion, to substitute a prize of equal or greater value if the Prize(s) (or any portion thereof) cannot be awarded for any reason.
- (h) The Sponsors shall not assume any liability for lost, damaged or misdirected Grand Prize.

6. WINNER SELECTION.

- (a) On or about August 26, 2022, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period.
- (b) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsor. Before being declared a Grand Prize Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
- (c) The selected entrant(s) will be notified by telephone or e-mail no later than August 26, 2022 at 5:00pm EST and must respond within five (5) business days of the notification. Upon notification, the selected entrant(s) must respond by telephone to the contact number provided in the notification, and the selected entrant's response must be received by the Sponsor within five (5) business days of such notification. If the selected entrant does not respond in accordance with the Contest Rules, he/she will be disqualified and will not receive the Contest Prize and another entrant may be selected at the Sponsor's sole discretion. The Sponsor is not responsible for the failure for any reason whatsoever

- of a selected entrant to receive notification or for the Sponsor to receive a selected entrant's response.
- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Contest Prize claimants after the Contest's closing date to award the final Prize.
- (e) The contest will be promoted across Facebook, Instagram and Twitter with only one (1) winner across all platforms.
