OFFICIAL CONTEST RULES AND REGULATIONS

1. KEY DATES:

The "Win Free Gas for a Year" Contest (the "Contest") begins on January 4, 2023 at 7:00 a.m. Eastern Time ("ET") and ends on March 15, 2023 at 11:59 p.m. ET (the "Contest Period").

2. ELIGIBILITY TO ENTER:

The Contest is open only to residents of Canada who have reached the legal age of majority in their province/territory of residence at the time of entry, except employees, representatives and agents (and those with whom such persons are living, whether related or not) of Suncor Energy Products Partnership ("Suncor") and Mazda Canada Inc. ("Mazda") (collectively, Mazda and Suncor referred to as the "Sponsor"), and each of their respective associated and affiliated entities, dealers, advertising/promotion agencies or any other individual(s), entity or entities involved in the development, production, implementation, administration or fulfillment of the Contest (collectively, the "Contest Parties").

3. AGREEMENT TO BE LEGALLY BOUND BY RULES:

By participating in this Contest, you are signifying your agreement that you have read and agree to be legally bound by these Official Rules and Regulations (the "Rules").

4. HOW TO ENTER:

NO PURCHASE NECESSARY, MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

To earn an entry in the Contest (each, an "Entry" and collectively, the "Entries"), make any customer pay service maintenance or repair purchase during the Contest Period from a Participating Mazda Dealer (an "Eligible Purchase"). A "Participating Mazda Dealer" is a participating Mazda dealer in Canada listed on the following website: https://www.mazda.ca/en/parts-service-campaign/. To qualify as an Eligible Purchase, a purchase must have a valid closed repair order issued by the applicable Mazda dealer. Over the counter purchases, warranty and recall works do not qualify as an Eligible Purchase. Transactions that are incomplete, cancelled or returned do not qualify as an Eligible Purchase. Upon completing an Eligible Purchase during the Contest Period in accordance with all requirements set out above, the owner of the vehicle associated with the Eligible Purchase (based on Mazda's official records as determined by Mazda in its sole and absolute discretion) will automatically receive one (1) Entry in the Contest. Limit one (1) Entry per Eligible Purchase. To be eligible, an Eligible Purchase and the entrant's participation in the Contest must be in accordance with these Rules (including, but not limited to, the specific Participation Requirements listed below), all as determined by the Sponsor in its sole and absolute discretion.

Upon receipt of your eligible Mail-in Request in accordance with these Rules (as determined by the Sponsor in its sole and absolute discretion), you will receive one (1) Entry in the Contest. To be eligible, your Mail-in Request must: (i) be received separately in an envelope bearing sufficient Canadian postage (i.e. multiple Mail-in Requests in the same envelope will be void); (ii) contain a unique and original handwritten essay, as set out above, that has not been submitted for entry in a previous Mazda contest; and (iii) be post-marked during the Contest Period and received prior to the Selection Date (defined below). The Sponsor takes no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed Requests.

IMPORTANT NOTE: Each Entry will be automatically allocated by the Sponsor to one (1) of the following Contest regions (each, a "**Region**"): (i) Pacific; (ii) Prairie; (iii) Ontario; (iv) Quebec; and (v) Atlantic. The allocation of an Entry to a Region will be based on either: (i) the Mazda dealer address associated with the corresponding Eligible Purchase; or (ii) the entrant mailing address associated with the corresponding Mail-in Request (depending on the applicable method of entry). All decisions regarding the Region in which a Mazda dealer is located or an entrant resides will be made by the Sponsor, in its sole and absolute discretion, and will not be subject to consultation or challenge.

5. ENTRY LIMIT AND CONDITIONS:

There is a limit of five (5) Entries per person and (as applicable) per Vehicle Identification Number, regardless of the method of

entry. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) exceed any of the limits stated in these Rules; (ii) use multiple names, identities, e-mail addresses and/or use any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or to disrupt the Contest; and/or (iii) disrupt or participate in the Contest in any other fraudulent or misleading way, then he/she may be disqualified from the Contest in the sole and absolute discretion of the Sponsor. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an entrant's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Contest-Related Information and/or other information entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with the letter and spirit of these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification in the sole and absolute discretion of the Sponsor. BY PARTICIPATING IN THIS CONTEST, YOU AGREE TO RELEASE THE RELEASED PARTIES FROM ANY AND ALL LIABILITY IN CONNECTION WITH THE CONTEST AND YOUR PARTICIPATION THEREIN AND TO INDEMNIFY THE RELEASED PARTIES AGAINST ANY AND ALL CLAIMS, DAMAGES, LIABILITIES, COSTS, AND EXPENSES ARISING FROM YOUR PARTICIPATION IN THE CONTEST. BY PARTICIPATING IN THIS CONTEST, YOU ALSO AGREE THAT YOUR ENTRY (AND EACH INDIVIDUAL COMPONENT THEREOF) COMPLIES WITH ALL CONDITIONS STATED IN THESE RULES. The value of each Prize is based on one (1) thirty (30) litre fill up per week (approximate average fill), at \$1.94 CAD per litre (the average annual Petro Canada price per litre), multiplied by fifty-two (52) weeks.

On April 17, 2023 (the "**Selection Date**") in Oshawa, Ontario (or such other location determined by Sponsor in its sole and absolute discretion) at approximately 12:00 p.m. ET, the Sponsor will perform a random draw to select one (1) Entry per Region (five (5) Entries will be selected in total) from among all eligible Entries submitted and received in accordance with these Rules during the Contest Period allocated to such Region to select the Prize winners. The odds of winning depend on the number of eligible Entries submitted and received in accordance with these Rules during the Contest Period per Region.

10. ELIGIBLE WINNER NOTIFICATION PROCESS:

The Sponsor or its designated representative will make a minimum of three (3) attempts to contact the potential winners within ten (10) business days of the Selection Date via email or telephone. A potential winner is solely responsible for ensuring he/she is able to receive such notification messages, monitoring for such notification messages and following all instructions contained in such notification messages, failing which, he/she may be disqualified (as determined by the Sponsor at its sole discretion).

11. ELIGIBLE WINNER CONFIRMATION PROCESS:

NO ONE IS A WINNER UNLESS AND UNTIL THE SPONSOR OFFICIALLY CONFIRMS HIM/HER AS A WINNER IN ACCORDANCE WITH THESE RULES.
